### 3. STATUS OF IALA BY SECRETARY-GENERAL AND RELEVANT STAFF

#### 3.2 MEMBERSHIP STATUS AND EVOLUTION

##### BACKGROUND

Since January 2020, IALA was joined by 1 National member, 5 Associates members and 14 Industrial members.

A new application for Industrial membership was also received on 18 June from China and is subject to the December Council approval.

##### APPLICATIONS

- The following organization was accepted as National Member: Service de la Navigation Maritime in Haiti. IALA counts 88 National members.
- The following organizations joined as Associate members: The Namibian Ports Authority, Nigeria Marine Coast Guard Voluntary Services, Port Authority of Kribi in Cameroon, Instituto Costarricense de Puerto del Pacifico in Costa Rica and Victorian Regional Channels Authority. This brings the number of Associates members to 70.
- IALA has also welcomed the following Industrial members: Crux Marine in Argentina, QinqDao Hotech Automated Technology Co Ltd and Ningbo Botai Plastics Technology Co Ltd in China, Maritime Atlantic Global S.A.S in Colombia, Sabik Offshore GmbH in Germany, Tridel Technologies Private Ltd in India, Harmoz Berkeh Ertebat Elektronik Gil in Iran, Norbit Aptomar AS in Norway, Invelco SA in Spain and International Transportation Mgmt P.A in the USA; AMG Microwave in France and Sternula ApS in Denmark. Industrial Members consist of 147 to date.

The membership growth is nevertheless impacted by some resignations and several terminations proceeded by the IALA Council in December for non-payment of contributions after the Secretariat had exhausted all efforts to collect their debts.

##### RESIGNATIONS AND TERMINATIONS

The IMC may note the following resignations from Industrial membership and terminations which took effect on 1<sup>st</sup> January 2020:

- **Resignations:** Oi Electric -United Marine from Denmark, Nesspoint (Ex Vissim) from UK.
- **Terminations:** The Babcock International Group in UK, Wujiang Xinhua Navigation Aids Manufacturer in China, Beacon Co in Egypt, L-3 Communications in the USA, Raad Bushehr Engineering Co in Iran, Depasa Marine International Ltd, Continental Shipyards Ltd and Dorrana Nigeria Ltd in Nigeria, Vesper Marine in New Zealand, Tide Technologies in Singapore and PMS Polietilen Mam San Tic A. S in Turkey.

An erratum is to be brought also on page 6 of the bulletin 2020/1 which announces Resinex Trading S.r.l in Italy as a discontinued member. This is not the case.


At Present, IALA counts 305 members and 42 Honorary members.

The Secretariat continues to receive a lot of interests in membership, especially from industries.


## EVOLUTION
