Report of the 44th Session of the IALA Vessel Traffic Services (VTS) Committee

Executive Summary

The 44th Session of the VTS Committee was held at IALA Headquarters from 25 to 29 September 2017.

87 Delegates from 28 countries, 2 sister organisations and 5 observers participated in VTS44. Significantly, this included 23 participants for the first time;

This was the seventh meeting for the 2014-2018 Work Programme and the VTS Committee considered 39 input papers and produced 16 output papers of three Working Groups.

Key outputs included:

The completion of the following new Recommendations and Guidelines:

- Guideline for setting and measuring VTS objectives;
- Recommendation on VTS Communications;
- Guideline on VTS VHF Voice Communication;
- Recommendation on Portrayal of VTS Information and Data;
- Guideline on VTS information exchange with allied or other services;
- Recommendation on Auditing and Assessing VTS.

Additions to the draft IALA Standard 1040 on VTS because of three new Recommendations.

The following liaison notes were prepared:

- To Council to approve the draft new Recommendations and Guidelines as given above;
- To Council on a workshop on harmonising the delivery of VTS communications;
- To Council on pro-active work prior to Work Programme 2018-2022;
- To ARM on the 2018 NAVGUIDE;
- To ARM on the Recommendation and Guideline of Mobile AtoN;

The SG approved a face-to-face intersessional meeting for the revision of IMO Resolution A.857(20).

The draft new Work Programme for the VTS Committee (2018-2022) was completed and reviewed. It will be forwarded to PAP34 for further completion after which it will be submitted to Council for approval.

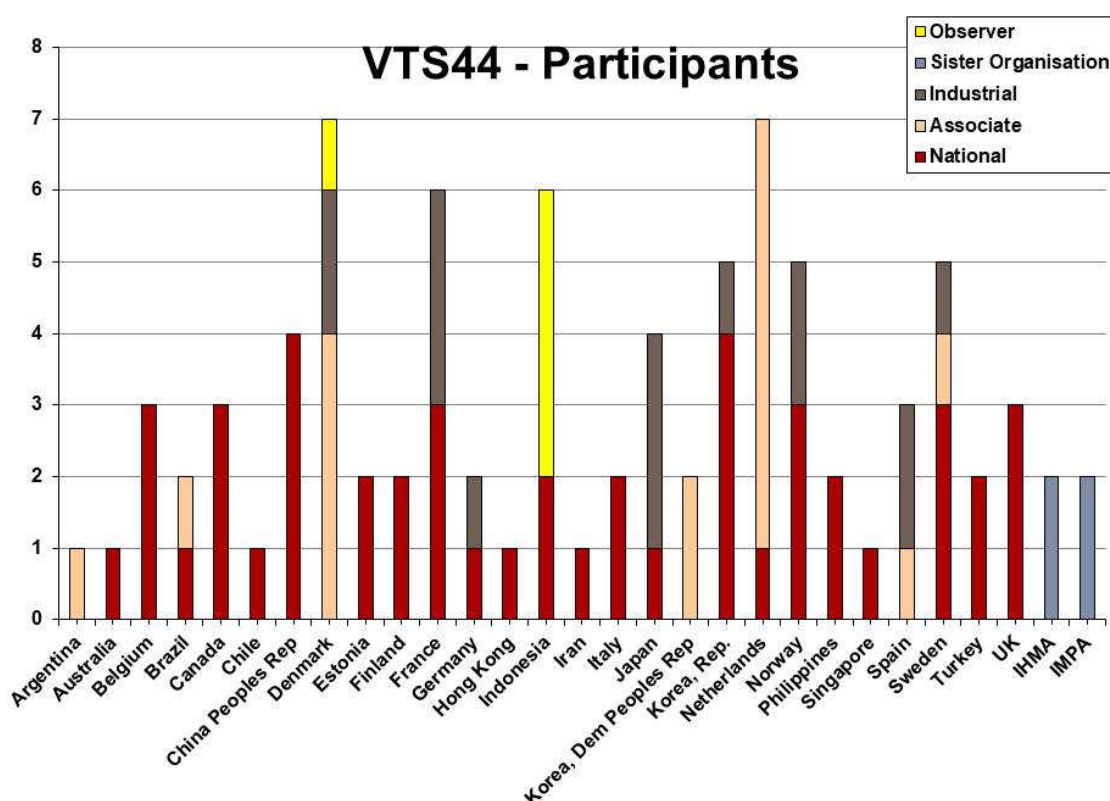

Report of the 44th Session of the IALA Vessel Traffic Services (VTS) Committee

1. INTRODUCTION

The 44th meeting of the VTS Committee was held from 25 to 29 September 2017 at IALA with Tuncay Çehreli as Chair and Neil Trainor as Vice Chair. The Secretary for the meeting was Wim van der Heijden.

87 Participants from 28 countries and 2 Sister organisations participated in VTS44; 23 for the first time. There were 5 observers.



The Deputy Secretary General Michael Card welcomed all participants to VTS44, in particular those returning after some absence and the delegates participating for the first time. He apologised the Secretary General because of an ITU meeting in Busan, Republic of Korea.

He mentioned that the renovation of the IALA office space is completed. He stated that this is the last meeting of the work period 2014-2018. Some changes of the Committee structures are in consideration e.g. work on resilient PNT will handed over from the ENAV Committee to the ENG Committee. Future IALA related events were attended:

- ENAV Underway North America will be in St. Johns, Newfoundland, Canada in October
- In the same week an IMO – IHO meeting will be held on data modelling
- FERNs, a Far East Navigation agreement between Korea, China and Russia
- IALA Seminar on Arctic Navigation, November
- Workshop on Maritime Connectivity (Maritime Cloud), November
- IALA Council meeting, December
- General Assembly Meeting, Korea, May 2018

The Committee Chair also welcomed almost 90 participants with the remark that 30% are participating for the first time.



1.1 Administrative announcements

Paper VTS44-1.1 (presentation) refers

The Secretary briefed some safety information which is also available at the registration desk.

He informed shortly about WiFi access, Fileshare facility and the printing facilities in the Lounge area.

He attended on the acronym used for Aids to Navigation which has been amended to Marine Aids to Navigation at PAP33 with AtoN as acronym. All text references should use Marine Aids to Navigation. The acronym MAtoN will be used for Mobile AtoN.

The following question was asked:

Does anyone present have the knowledge of any patents, including pending Patents, held either by themselves or by other organisations or individuals, the use of which may be required to practice or implement the content of IALA Documents being developed or worked on in this Committee?

No patents were noted.

1.2 Approval of the agenda

The agenda was reviewed and adopted (VTS44-1.2).

1.3 Introductions and apologies

The Chair welcomed the new participants of the Committee. At that moment some apologies were received as listed in Annex B.

1.4 Programme for the week

The Chair explained the programme for the week (VTS44-1.4) which was adopted.

2. REVIEW OF ACTION ITEMS FROM VTS43

Input paper VTS44-2.1 refers.

2.1 Action Items – IALA Secretariat

Action item 6, on the proposal to review IMO Resolution A.857(20), was approved in principle by Council and directed the IALA Secretariat to finalize it, taking into account comments from the Councilors.

It was noted that all other IALA Secretariat actions from VTS43 had been completed.

2.2 Action Items – VTS Committee Participants

Action item 26, 29 and 30. No inputs or comments were received.

Action item 28 (effective communication). New input was received for further consideration during the meeting.

3. REVIEW OF INPUT PAPERS

Input papers are numbered in line with the agenda.

There is no input on agenda item 3.1, IALA Standards. The Chair informed that the final approval of the seven Standards would be during the Council 65 meeting in December 2017 and then go for approval at the General Assembly meeting in 2018.

The following input papers were reviewed and appointed to the working groups with the following remarks:

- VTS44-3.2.1 on the International Workshop on Next Generation VTS is now a full report. During VTS43 just the summary was input (VTS43-3.2.9). Noted.
- VTS44-3.2.2 on Voice Alerting System will be followed by a plenary lunch presentation on Tuesday. Noted
- VTS44-3.2.3 on NI approach of Training Accreditation will be followed by a presentation for WG3 on Monday. Noted.
- VTS44-3.2.4 on a proposed workshop on Global Harmonisation of VTS Operational Delivery will be considered by WG1. It was remarked that it is scheduled at the same time as ENAV Underway Pacific which is in Seoul, Republic of Korea. DSG, Chair and the Korean delegation will discuss this further during the week.
- VTS44-3.3.1 and VTS44-3.3.5 will be reviewed by WG1.
- VTS44-3.3.2 will be reviewed by all WGs, WG1 will co-ordinate.
- VTS44-3.3.3 will be considered by Kevin Gregory and Tom Southall.
- VTS44-3.3.4 Noted.

4. REPORTS FROM OTHER BODIES

4.1 IALA Council

The Committee noted the Council report, 64th Session, IALA, June 2017, paper VTS44-4.1.1 refers.

The Chair informed briefly about the report and the VTS related issues:

- The name change of Task 2.3.1 to Guideline on technical aspects of VTS information exchange between VTS and allied or other services was approved.
- The submission to IMO MSC on an update of MSC Circular 1065 on the IALA standards for training and certification of VTS personnel was approved.
- The withdrawal of IALA Guideline 1032 was approved.
- The submission to IMO MSC on the revision of IMO Resolution A.857(20) was approved in principle. See also chapter 2.1 above.
- Revision of Recommendation R0103 (V-103) was approved.
- The removal of Task 1.2.1 on the preparation of a guideline on public and media relations in special circumstances from the current work programme was approved.
- The name change of Task 1.1.6 on the production of a Guideline for setting and achieving VTS objectives was approved.

4.2 IALA Policy Advisory Panel

The Committee noted the PAP33 report, paper VTS44-4.2.1 refers.

The Chair briefly introduced the report and VTS related matters. PAP33 recommended Council to have definitions in the individual Recommendations and Guidelines again after they have been checked against the Dictionary. This was approved during the Council 64 meeting.

Just before VTS44 the second Joint VTS – ENAV meeting was organised, open to Committee and Working Group Chairs and Vice Chairs of both Committees. It was a productive meeting to improve the communication and co-operation between the two Committees.

4.3 IMO

Input paper VTS44-4.3.1 of NCSR4 refers.

The Committee noted the report of NCSR4. A verbal report was already given during VTS43.

As no report of the 98th session of the Maritime Safety Committee (MSC98) as input was received the Chair highlighting two issues:

- MSC revoked its Circular related to the World VTS Guide and noted that the reference in Resolution A.857(20) is no longer valid;
- MSC98 approved a new output proposal on maritime autonomous surface ships.

4.4 ITU

Input paper VTS44-4.4.1, VTS44-4.4.2 and VTS44-4.4.3 refers.

It was reported that the ITU-WP5B input documents were produced by the ENAV Committee and relates to the new version of the Maritime Radio Communications Plan (MRCP). After Council approval it will be published on the IALA web and IMO NCSR will be informed.

5. REPORTS FROM RAPPORTEURS

5.1 Risk management toolbox

Rapporteur: Tuncay Çehreli

The IALA World-Wide Academy, in conjunction with China Maritime Safety Administration organized a training seminar on the IALA Risk Management Toolbox from 11 to 15 September 2017 at Jimei University, Xiamen, China.

The seminar has provided an international and regional overview of risk management and importance of stakeholder liaison before demonstrating the value of the IALA Risk Management Tools.

The other development since VTS43 is the production of three risk related documents by ARM Committee. Those are;

IALA Guideline G1124 – The Use of Ports and Waterways Safety Assessment (PAWSA) MkII Tool

IALA Guideline G1123 – The Use of IALA Waterway Risk Assessment Programme (IWRAP MkII)

IALA Recommendation R1002 – Risk Management for Marine Aids to Navigation

R1002 recommends the use of risk management and IALA risk management tools as part of the decision-making process for Marine Aids to Navigation. The Recommendation is expected to be normative in the draft Standard 1010. It supersedes Recommendation O-134.

6. PRESENTATIONS

6.1 IALA World-Wide Academy (WWA)

Paper VTS44-6.1 (presentation) refers.

The presentation was made by Omar Frits Eriksson.

The presentation showed some traffic density plots to illustrate the relationship between the amount of traffic and the Accredited VTS Training Organizations. It showed that there are gaps between the existing training

organisations and those in need. The WWA made over 1200 Recommendations in 30 missions to advice members.

6.2 Vessel Monitoring and Voice Alerting System for VTS

Paper VTS44-6.2 (presentation) refers.

The presentation was made by Xinli Lv.

A system is developed and presented for automatic voice warnings for collision risks and warnings in different situations. The presentation was followed by a discussion.

The Chair thanked all speakers for the presentations.

7. ESTABLISH WORKING GROUPS

The Chair outlined the procedure to be followed by working groups, including the associated paperwork, after which three working groups were established and their tasks outlined. A list of working group participants is at Annex C.

8. WORKING GROUP 1 – TD#1 - OPERATIONS (WG1)

41 participants were involved in working with the tasks of WG 1. Four subgroups were created to consider the tasks during VTS44, as follows:

8.1 Task 1.1.4 Produce a Guideline on Maritime Service Portfolios for VTS

The sub-working group assigned to the task 1.1.4 revised the working document from VTS43 “IALA Guideline Maritime Service Portfolios: Digitising Maritime Services” for MSPs 1, 2 and 3 and the document drafted by the ENAV committee (VTS44-3.3.5(ENAV21-14.2.5)).

This work will continue by correspondence to progress and an input paper will be provided for VTS45 and joint ENAV-VTS working group.

This group identified the need to provide VTS-focused user requirements for operational and technical services for other relevant remaining MSPs as well as potential additional VTS-related MSPs during the next working period.

The group noted a need to work jointly with the technical working group to develop Common Maritime Data Structure (CMDS) entries for the MSP1, MSP2 and MSP3 for next Work Programme.

The group noted that detailed guidelines on Maritime Service Portfolios for VTS should be developed after the completion of the IALA Guideline entitled: Maritime Service Portfolios, Digitising Maritime Services is finalized by ENAV and approved by Council. In order to achieve this, it is requested that the VTS committee extend the task to the next work program and approve a workshop on this task.

Action item:

*The **Committee Secretary** is requested to forward the draft Guideline on MSP (VTS44-12.2.1) as working paper to VTS45 for further development.*

8.2 Task 1.1.6 Produce a Guideline for setting and achieving VTS objectives

The Working Group reviewed and made significant changes in the draft guideline which were finalized. The review focused on that the guideline should be concise and simple so that the purpose of identifying and measuring VTS objectives can be achieved. The title of the Guideline was also changed to read: “Guideline for setting and measuring VTS objectives” since that covered the content better.

Action item:

*The **Committee Secretary** is requested to forward the Guideline for setting and measuring VTS objectives (VTS44-12.1.9) to Council for approval.*

8.3 Task 1.3.1 Produce a Recommendation / Guideline on VTS Communications

The VTS communications sub-group had a successful meeting and lots of input was received and discussed by all participants in the group. Work was progressed sufficiently enough that both the Recommendation and Guideline were completed. The title of the Guideline was changed to read: “Guideline on VTS VHF Voice Communication”.

Action item:

*The **Committee Secretary** is requested to forward the Recommendation (VTS44-12.1.11) and the Guideline (VTS44-12.1.10) on VTS Communications to Council for approval.*

8.4 Task 1.4.2 Review/update/provide input to IMO on Resolution A.857(20) Guidelines for VTS

The Working Group discussed the consequences of an interruption of one year on the work concerning the revision of IMO Resolution A.857(20) and concluded that the interruption is undesirable and probably will lead

to not achieving indicated deadlines (e.g. completion of revising the resolution within the biennium 2018-2019). Therefore, intersessional work (between VTS44 and VTS45) on this task pro-actively to the Work Programme 2018-2022, is recommended and needed.

The Committee drafted a liaison note to Council, taking into account approval procedures by the SG for intersessional work, with a request to note the information, the considerations and the proposal for intersessional work on the revision of Res. A.857(20).

The Committee also drafted a request to Secretary-General for the approval of a face-to-face intersessional meeting 10-13 April 2018. The request was approved during the meeting for 10 – 13 April 2018.

Action items:

*The **Committee Secretary** is requested to forward the liaison note on pro-active intersessional work on the revision of IMO Res.A857(20) prior to Work Programme 2018-2022 (VTS44-12.1.1) to Council to note.*

Miscellaneous

8.5 VTS44-9.3.1 WG2 Task 2.3.1 Draft Guideline on the interaction with other stakeholders

The Working Group reviewed and responded to part of the guideline after request from WG2.

8.6 Review Guideline 1101 Auditing and Assessing VTS with a view to create a new Recommendation

The Working Group acknowledged the input from the vice-chair of the Committee and reviewed and finalised the Recommendation on auditing and assessing Vessel Traffic Services.

Action item:

*The **Committee Secretary** is requested to forward the Recommendation on auditing and assessing Vessel Traffic Services (VTS44-12.1.12) to Council for approval.*

8.7 VTS44-3.3.1 (ARM6-12.1.13) Liaison ARM to VTS on MAtoNs VTS44-3.3.2 (ARM6-12.1.23) Liaison ARM to all Committees on mobile AtoN

The working group responded to the request from ARM Committee on MAtoNs (VTS44-3.3.1) and forwarded text proposals on both the Recommendation and Guideline on MAtoN.

The Committee was also requested by ARM Committee (VTS44-3.3.2) to consider any innovative solutions which may provide for the new requirement and advise the ARM committee accordingly, but regrettably no proposals were forthcoming from members of the VTS Committee.

Action item:

*The **Committee Secretary** is requested to forward the liaison note on MAtoNs (VTS44-12.1.13) together with Annex 1 Recommendation on Mobile Aids to Navigation (MATON) (VTS44-12.1.14) and Annex 2 Guideline on Use of Mobile ATON (VTS44-12.1.15) to ARM for further considerations and to include a comment on VTS44-3.3.2 that no proposals were made by the members of the VTS Committee.*

8.8 VTS44-3.2.4 Proposal workshop on harmonising the delivery of VTS communications

The Committee was requested to consider the organisation of a workshop on “the Global Harmonisation of VTS Operational Delivery”. It was noted that there were other events at the proposed time for the workshop and therefore the submitter informed that the date of the proposed workshop can be altered to be hold in spring 2019.

The Committee was positive for holding a workshop on harmonising the delivery of VTS communications and supported the new proposed timing for the workshop in spring 2019. A revised workshop proposal was completed for further considerations of the Council for the next Work Programme. The Committee also agreed to arrange the workshop back-to-back with VTS46, dates yet to be confirmed.

The Korean Coast Guard will respond to the proposal for the back-to-back event by 30 October 2017.

Action item:

The **Committee Secretary** is requested to forward the liaison note to organize a workshop on VTS Communications including a workshop proposal (VTS44-12.1.8) to Council for further considerations and approval.

9. WORKING GROUP 2 – TD#2 - TECHNOLOGY (WG2)

Introduction

21 participants joined the Working Group.

Tasks were presented as follows:

The WG2 had 5 papers to review, update, note and comment upon.

- VTS44-3.2.2 Liaison note from ARM to all committees on MAToN
- VTS44-9.1.1 Produce a Recommendation on Portrayal of VTS Information and Data.
- VTS44-9.2.1 Produce a Guideline on Acceptance of VTS Systems
- VTS44-9.3.1 Produce a Guideline on technical aspects of VTS information exchange between VTS and allied or other services
- IALA Guideline on Recommendations and Guidelines relating to VTS

After presenting these tasks the Working Group discussed the approach to the management of these tasks and agreed a plan for the week. Essentially, three sub-groups were created along similar lines to the previous sessions.

9.1 Liaison note from ARM to all committees on MAToN

The workgroup had no comment to this liaison note

9.2 Task 2.1.1 Produce a Recommendation on Portrayal of VTS Information and Data.

No comments received between VTS43 and VTS44, and the Working Group seeks the committee's approval to finalise the document for approval.

Action Item:

The **Committee Secretary** is requested to forward the draft Recommendation on Portrayal of VTS Information and Data (VTS44-12.1.6) to Council for approval.

9.3 Task 2.2.1 Produce a Guideline on Acceptance of VTS Systems

Good progress was made on this task. The output is a working document which should be referred to VTS45 as an input paper. The task was scheduled for completion at VTS44; however this will go into the next working period, and will be scheduled for completion in the middle of next work period, as we need to ensure it aligns with any updates we make on Guideline 1111.

Action Item:
